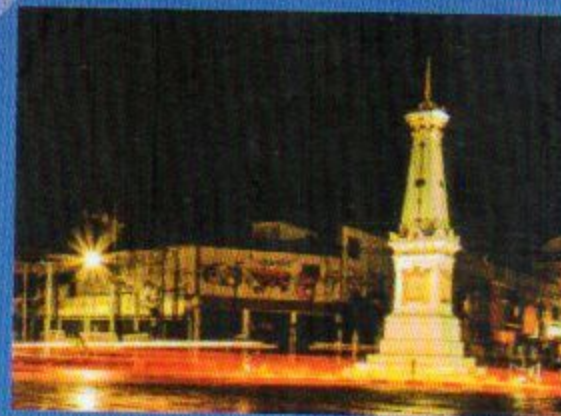

ABSTRACT

This research aims at revealing the implication of verbal abuse from parents or teachers to the students of Mataram Junior High School Bantul. This is a descriptive qualitative research. There are 7 subjects of this research; they are the headmaster, counselor and guiding teacher, civic teacher and 4 students that are naughty. Technique of data collection are observing, interviewing and documenting. Qualitative analysis was employed to analyze the data. The results of this research are: (1) students have no sensitivity regarding somebody else's feeling, (2) They have no confidence, (3) The children or the students lack of ability to think broader to solve the problems they are facing, (4) They are aggressive, (5) they miss the class often, (6) They like to being liar, (7) They like to steal somebody else's belonging, (8) They become a member of naughty society, after all, they commit to suicide.

INTRODUCTION

Children are social creatures that need other people. Attitude and behaviour development are influenced by home or other social environments, however, the main influence is from the inside. This is parents' responsibility about the development and growth of the children.

Under poverty and less educated parents, while caring the children, it is less than required because the parents are very busy to fulfil the basic needs to live, even it is hard for them to provide three times dining and less nutritious. It causes the children try to find caring and loving from outside the home. Children's character change through the time, together with the age, they need special attention from the family. Father and mother's roles are needed to care, keep and protect them. Father's roles are to protect and fulfil the basic needs to live. It is a must that parents' love and caring are attempted to build, and it should be.

A child starts to rebel with everything surroundings without any objection from the parents, and it will make him to have unstable emotion. When parents start to complain about children's acts, it challenges him. There will be such a kind of problem between children and parents. Children that grow with loves from people all around will develop the confidence and secure from inside. On the other hand, The ones that have lack of love and caring will not have the feeling of secure and lack of trust towards the surroundings (Lusi Nuryanti, 2008:25).

The researcher found various problems that rose from the way parents treat the children and it causes the children naughty and wrong to choose friends. Parents are lack of understanding about the children's needs. If parents and the children argue to each other without any attempt to listen to each other, it will not finish the problem. As a matter of fact, it will raise another new

problem with the possibility the children being abused.

Whenever parents are busy with the job outside, it influences the children. They still need parents' attention, love and caring. Parents are busy to earn money while the children need to be someone who is being complimented, being the focus of parents attention. Parents sometimes make the children the waste basket, to throw the rubbish of office's problems, say rude words. Actually it makes the children imitate everything from us, good or bad. Home is not the only place that characterizes the children; the school is just the same. We sometimes found that a child addresses another child by using a silly name. For the one who is being address, it is just ashamed.

Research Problem Formulation

Based on the background and problem limitation that have been explained before, the research problem formulation is: What is the implication of verbal abuse of parents and teachers towards the students of junior high school Mataram Bantul?

Research Objectives

The objective of this research is to reveal the implication of verbal abuse from parents or teachers towards the students of Mataram junior high school Bantul.

Theoretical Framework

Verbal abuse or it is more known as emotional child abuse, is the spoken or acted behaviour that raises bad consequences. Verbal abuse happens when a mother or a caretaker ask the child to be quite. The child is asking attention. Whenever the child does not want to stop crying, the mother or the caretaker use rude words such as "you stupid". The children, who are being treated like this will become someone who is introvert, shy, easy to cry and so on.

The form of verbal abuse according to government regulation number 23 year

2002 are rejection, insult, threat and isolation.

The effect of verbal abuse can influence the children's psychology (Setiawati, 2006), such as: interfere the development, the low of self-concept, aggressive, emotion disturbance, even committing suicide.

RESEARCH METHOD

This is a qualitative research, conducted in Mataram Junior High School Kasihan. The subjects of this research are a headmaster, Counselling and guiding teacher, a civic teacher and 4 students that need special attention, meaning that they are naughty. The technique of collecting data is by observation, the researcher visited the school to observe the school condition and conducted interview with the research's subjects to gain the data being required based on the questions that have been prepared. The documentation are such as school archive containing information about the teachers, students and parents. Qualitative data analysis was employed to describe written and oral information given by the ones who were interviewed.

Research output and discussion

Based on the interview conducted during the research process, 55% parents are labourer, 5% are illiterate. There are 18 male students and 8 female students that need special attention based on interview with counsellor and guidance teacher. However, the researcher conducted interview only on 4 students. Below is the table of students' amount from 2013/2014 up to 2016/2017.

Most of Mataram students are from under poverty parents and low education level. These facts cause the way to care and love the children is not good, even the children who are born because of the victim of rape violation. The researcher gained these data from the teacher of counsellor and guidance and also the teacher of civic of these kinds of students.

Based on the result of interview, the factors that make the parents commit to do the abuse are as follows: the first is parents' knowledge regarding children education and lack knowledge of religion. This leads to the parents' way to say stupid, not useless and others that categorized as insulting. Second, the parents are the victim of raping. Third is economic factor. It makes parents easy to make the children as the source of any mistakes. Fourth is surrounding factor. Dirty area will bring bad consequence on how people and children act.

This research compares family that is democratic and the one which is fully authority. Those are: The children who are rose in the democratic family tend to have initiative, have courage to state ideas, full of life purposes. On the other hand, the children who are rose in the fully authority family will not fully obedience, eager to insult others, become more stressful and restless. If they are female, they will choose to keep themselves in the room, crying.

CONCLUSION

Based on this research it can be conclude that the implication of verbal abuse from parents and teachers towards the students of Mataram Junior High School Bantul: Children will lack of sensitivity to others. It causes the words are rude, less of confidence, stressful and hard to think farther. They get difficulty in solving problems, aggressive, not blend with others, missed the class often, liar, become thieves and finally committing suicide.

Implication

The implications of verbal abuse are words are rude, less of confidence, stressful and hard to think farther. They get difficulty in solving problems, aggressive, not blend with others, missed the class often, liar, become thieves

Suggestion

1. To the teachers

It is hoped that teachers educate, guide the students who were treated bad from parents to give more attention to have better personality.

2. To parents

It is hoped that parents love and care and say something gently to children so that they grow become people with good personality and high confidence.
